

Experience Rashi Kindergarten! 2023-2024 Application

In order to be considered for this grant, you must first apply for admission through <u>Rashi's Veracross</u> <u>Portal</u>.

Experience Rashi Kindergarten! is a three-year grant for new families with a child currently attending a Jewish preschool and applying to Rashi's Kindergarten for the 2023-24 school year. This is available to families whose Adjusted Gross Income is between \$175,000-600,000 with net assets under \$500,000*. Under the *Experience Rashi Kindergarten!* program, families will benefit from three years of fixed tuition:

\$20,000 for Kindergarten in 2023-24 \$22,500 for Grade 1 in 2024-25 \$25,000 for Grade 2 in 2025-26

*\$500,000 in assets not including retirement savings and primary residence.

The *Experience Rashi Kindergarten!* grant is available to 10 students from new families who apply to Rashi by November 21, 2022.

Instructions: Make sure to have on hand the Adjusted Gross Income of both parents/guardians as you have reported on your 2021 IRS Individual Income Tax Return.

After completing the application, please print and sign. Remember to keep a copy for your records.

To be considered, your application packet must include the following:

□ Copy of both parents'/guardians' **2021 IRS Form 1040** (pages 1 and 2 only).
